## Instructions for obtaining an IRS Verification of Non-Filing Letter

All non-tax fliers are required to provide an IRS Verification of Non-Filing Letter dated on or after October 1, 2022, that indicates that a 2022 IRS income tax return was not filed with the IRS.

- Online Request Go to www.irs.gov/transcript, click "Get Tax Record"
- "Get Transcript Online" Make sure to request a 2022 Verification of Non-Filing. Note: If at any point you cannot validate your identity using the "Get Transcript Online" option, you may use the "Get Transcript by Mail" option. This option takes about 5-10 business days.
- Paper Request Form IRS Form 4506-T follow form instructions.
- Telephone Request Call the IRS automated phone transcript request service 1-800-908-9946.
